It provides no limitation on this pardon power. It has been consistently interpreted to be virtually unlimited. This view was upheld in the latest Supreme Court decision on pardons, SCHICK vs NEED, 419 U.S. 256 (1974). WHAT DOES THIS MEAN? IT MEANS THAT BILL CLINTON CAN PARDON ANYONE THAT HAS EVIDENCE AGAINST HIM, HILLARY OR THEIR FRIENDS, IN RETURN FOR THEIR SILENCE. IT ALSO MEANS THAT UNDER THE U.S CONSTITUTION - BILL CLINTON CAN PARDON BILL CLINTON!

LOOK IT UP!

It seems evident that the DNC, DEMOCRATIC NATIONAL COMMITTEE, MAY have violated existing criminal statutes when it accepted INDONESIAN and SOUTH KOREAN contributions. 2 U.S.C. 441e, says "IT IS UNLAWFUL FOR A FOREIGN NATIONAL TO DIRECTLY, OR THROUGH OTHERS, CONTRIBUTE TO ANY POLITICAL CAMPAIGN, OR FOR ANYONE TO SOLICIT, ACCEPT OR RECEIVE SUCH CONTRIBUTIONS."
