

THE TREASON TREATY

On December 9, 1948 the United Nations general assembly passed the convention on the "prevention and punishment" of the crime of Genocide, more commonly known as the Genocide Treaty. On its face and to the ignorant masses, the purpose of the treaty is to simply prevent the mass murder of members of a national, ethnical, racial, or religious group. As a result, many people stupidly fall victim to its propaganda. However, the truth is much more dastardly than most people can even imagine.

If you cause even so much as "mental harm" to a person belonging to a racial, religious or ethnical minority you would be guilty of Genocide. For example, suppose you should read one of the many passages from the Bible that condemns the Jews for every thing from sex perversion to murder, Jews would claim that you have caused them undo mental harm and charge you with genocide. You could then be sent to Israel where you would stand trial before a world court. No constitutional rights would protect you. Of course, the Jews are loving and understanding people and they don't want you to face such terrible consequences; so in order to protect you, the bible would be rewritten by a "competent and trusted scholar" so the offending passages can be removed, (in the interest of brotherhood).

The proponents of the Genocide Treaty continually clamor for its passage. In past years it has been defeated by, knowing patriots.

Even Ronald Reagan has promised his support to get the Genocide Treaty approved and into law. Political observers have noted that even right wing members of the Senate, and Congress have buckled under to Reagan's whims and approved the treason treaty.

If the Genocide Treaty does become the law of the land and usurp the Constitution, then the will of every freedom-loving man and woman will be put to the final test.

If this Treasonous Treaty becomes law it will in effect give the United Nations authority to intervene in the domestic affairs of our nation and subject us to a super one-world humanist government.

It must be opposed as a threat to our sovereignty as a nation and to our individual freedom.

Our Constitution contains a dangerous loophole by which our national sovereignty can be eroded or, even worse, wiped out in one final swoop! Article IV, Paragraph 2 of the Constitution states in part: "...All treaties made, or which shall be made, under authority of the United States, shall be the supreme law of the land; and the judges of every state shall be bound thereby, anything in the Constitution or laws of any state to the contrary, notwithstanding."

This means simply, that all treaties override the Constitution and legally bind the American people both as a nation and as individuals.

The word Genocide was coined by Dr Raphael Lemkin and means "the intentional and systematic killing and extermination of a whole people or nation. Who then could fail to be against Genocide in act and in principle?

If the treaty confined itself to this definition, few could or would oppose it. In reality, this definition is not set forth in the text and bears only the remotest relationship to the categories of crimes defined.

Study of the treaty shows that it goes far beyond its announced objectives. By exempting political and revolutionary groups, it reveals itself to be a cunning tool against our national survival. This tool could be easily
