## "Our Ninth Year"

Dear Friends and Partners:

Greetings in the name of our wonderful Lord of Creation!

From time to time I like to share my vision with you -- a vision of the future for The Legal Defense Fund. We have had nine years of effective ministry and we have made a difference in this land.

However, there are still battles to fight and victories to win. Let me share with you my vision for six areas of ministry which we should emphasize during the months ahead.

### Clearinghouse

We should make all our resources available to help the people in various states who want information on how to get bills through the legislatures that require certain things, including: (1) the teaching of non-evolutionary views of origins; and (2) teaching that information which refutes evolution. This has been accomplished in Texas and Alabama and I believe it will spread to other states as well. We also must be prepared to provide information to parents, teachers and students, telling them what their rights are and how they should approach their teachers, principals and school boards to make sure that the non-evolutionary views are taught.

Through the years The Legal Defense Fund has helped large numbers of people who had questions or were facing problems in their schools.

We have also noticed a number of cases of harassment, ridicule and persecution of some of our young people who refuse to bow down to the evolutionary viewpoint. This is wrong and there are numerous laws which protect our children from this disgrace. These people must be told about those laws! We must stand ready to share all the information available to us with those who come to us for help.

### Radio, TV, Newspapers

From time to time we receive requests for radio, television and newspaper interviews on the subject of Creation/evolution. Such requests usually are tied into breaking news stories of some national interest. Often, we are the first ones the news media calls for comment from the Creationist point of view.
