Many thanks for your letter of December 29.

Although I am anxious to visit the Northeast as soon as it is practicable to do so, I have now concluded that I should not come during January as tentatively planned at one time. The considerations which you mention as favoring a visit after March 15 prevail. Thus I am now planning on coming the second half of March.

The schedule which you indicated would be fully acceptable to me, and would embrace all the thoughts I had on the subject. I am inclined to agree with you that I should not spend too much time calling on military, although if it were possible to make a single call without offending others I would like to do so.

I would plan to take in Salvador during the same tour, and your suggestion also of going to Fortaleza, at least for a few hours, is appealing. This would depend in part on how much time I can devote to the trip, and I will be letting you know more about this at a later date.

The suggestions which you made concerning my wife will be fine. She does enjoy golf and will plan to bring her clubs with her. Apart from that, and participating in any social functions which it would be desirable for her to attend, her main interest would be in sightseeing. She would, of course, be prepared to call on wives of senior officials as may be appropriate.

There are other possibilities which you may wish to consider. For example: a reception arranged by the American Women's Club at the American School to meet the American community; a reception at our home mostly for Brazilian officials and leading local citizens; and, a walk-through of the Consulate, USAID, USIS, and Peace Corps offices.

There are all sorts of alternatives, of course. For example, if you arrived in the late afternoon or very early evening, one of the receptions could be held that first day, and you could leave in the afternoon of the third day. You may also wish to take in Fortaleza, less than two hours away by air.

I don't know what your thoughts are concerning calls on the commanders of the three military branches here. The Fourth Army General is rather important, as you know. But if you visit with one, it would be courteous to call on all three, a time-consuming operation. I would suggest not making these calls, but inviting them to your reception. (Ambassador Elbrick followed that procedure.)

We expect and would be pleased to arrange a program for Mrs. Rountree, including golf, which, if I recall, you mentioned she thoroughly enjoyed.

As to timing, there are good reasons to come in January and other good ones to delay your visit. On the one hand, having visited elsewhere, it would be fitting to come up to the Northeast as soon as convenient. On the other hand, the new Governor, probably the new Mayor, and certainly a new SUDENE Superintendent will be on hand after March 15. I had suggested we time a loan signing in Recife with your visit. This might also be a factor, but at the moment, I don't know when the sewer loan will be ready.

At your convenience, we'd appreciate knowing of your wishes and preferences, and those of Mrs. Rountree. If you think it would be useful, I would, of course, come to Brasilia to discuss this with you. We should know, also, what security arrangements you consider appropriate. However, Pernambuco is very thorough and rather competent in these matters and will wish to have an

important, if not decisive say on how your security is provided for.
