

Anxious to testify before ANY Congressional Committee, Admiral McMillian tried hard to appear before the Watergate and Rodino committees. Rodino personally wanted him to testify but was apparently scared into suppressing his star witness for fear that his Republican election opponent would be financed to the hilt by the conspiracy.
