

If you are ever in this area on a weekend or on time off, I believe you would find it most rewarding to visit. I wish that I could have your youth to help us with a program at Amherst, Mass. Amherst is at the bottom of the intellectual ladder as far as fluoridation. It is unbelievable that approximately 98 professors out of 100 could be influenced to believe in, vote for, and/or promote fluoridation, thus becoming mouthpieces for the promoters and lobbyists representing plus or minus 200 companies supplying the fluorides and those individuals in state and federal government who are unpaid salesmen in this hideous criminal act.

- (5) The excerpts of Judge Tartar sum up what I have said. Tom will tell you about big law suits that were won in Pennsylvania, Illinois, Scotland, and many more, but promoters of fluoridation are above the law, using people with so-called legislative power to protect their criminal acts.

- (6) I am enclosing a copy and record of the illegal criminal act that took place at Grand Rapids, Michigan, in 1945. To verify what you will read, I suggest that you write to the city of Grand Rapids in care of the Clerk and request the date that fluorides and fluoridation were officially recommended and approved by the City Council. The dentists and the public and the people of Grand Rapids are not allowed to know, as you will read, that Grand Rapids was selected for an experiment by the federal government and those they influenced. If Grand Rapids had been in Germany during the Nuremburg trials in the 1940's, untold individuals should have been jailed, fined, executed for their part in selecting people of Grand Rapids without their consent or knowledge, people of all categories. Experimental work on humans or groups of humans is forbidden by our federal government.

The adding of fluorides to military posts, army/navy/air force/marines, is one of our government's biggest scandals. This was done without an Act of Congress. It was done by Gen. Armstrong, and in his own words, "The decision of the Surgeon General of the Army is final and decisive."

- (7) The illegal fluoridation of the District of Columbia by Congress is another national scandal.

The fluoridation, as promoted by our government, is the biggest political payoff in history. An attorney for the Aluminum Corporation of America (ALCOA) became the major fundraiser for the Democratic party and Harry Truman in the 1940's. Oscar Ewing became a personal friend of Pres. Harry Truman. Oscar Ewing's reward was to be made head of the Federal Security Agency, made up of 17 departments including the U.S. Public Health Service, FDA, etc.

- (8) Enclosed are recent letters from the U.S. government that should whet your appetite. As you will see, our FDA, as of this date, does not recommend fluoride supplements. You will see that fluorides used in water are a long-standing problem to industry, especially the fertilizer industry, and rather than further polluting the soil and water with these waste products, the EPA believes it's wonderful to add fluorides to drinking water. You will also see that no experiments have ever been offered to our FDA for its examination and approval.
