But the suit by *Penthouse* is a new and serious threat. If successful, it could shut down your national AFA...and silence your protests against pornography and anti-Christian bigotry.

I don't pretend to know your financial situation right now. The recession has been tough on everybody (including your AFA).

I do know your past generosity to AFA, and I thank you from the bottom of my heart for your support.

Don't let *Penthouse* shut you up.

A victory in this lawsuit will be a great boost for us to continue to have our First Amendment rights. And be a major embarrassment to *Penthouse*.

Please help defend your AFA as best you can today.

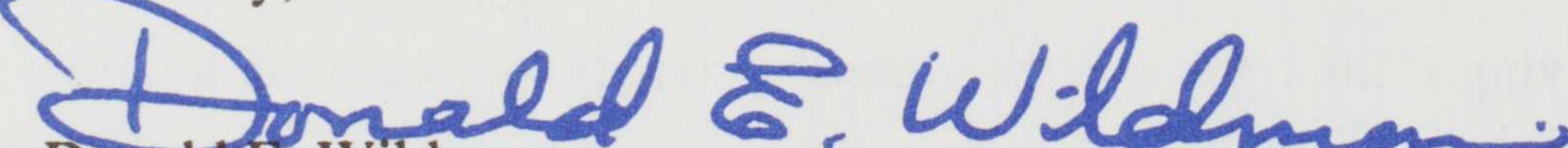
And while you're at it, renew your efforts in the boycott against Kmart. Take the following actions:

1. Sign and mail the enclosed postcards to Chrm. Antonini and to the manager of the local Kmart store if there is one in your area. (Better yet, write a personal letter. If you can't do that, put the enclosed card in an envelope and mail it. You can find the address for your local Kmart store in your phone book.)

2. Call Kmart and let them know you are boycotting. The number is 1-800-63-Kmart (1-800-635-6278). Kmart is keeping track of the phone calls so your call is very important. You may be told that Kmart has nothing to do with Waldenbooks. This is not true. Kmart owns Waldenbooks and has the authority to tell Waldenbooks to get out of the pornography business. As always, be polite when calling.

In closing, please say some extra prayers for me and AFA at this time. Even though I am prayerfully confident of victory, this is still an additional pressure I have to carry. I survive because of your prayers. Thank you and God bless you.
